Gifts in wills form

Thank you for considering a gift in your will in support of children, youth, and adults with diverse abilities.

Creating a legacy gift enables you to make a lasting difference while retaining full use of your assets during your lifetime and frequently offers estate tax advantages that benefit your family and heirs after your death. A legacy gift to Clements Centre Society (Charitable No. 107269466 RR 0001) can also provide significant tax advantages.

- You can create a meaningful legacy by designating your gift to Clements Centre Society and, if you wish, to a priority area that matches your interest with the organizations future plans
- A bequest is tax-effective - your estate may claim gifts in the year of death equal to 100 per cent of your net income in that year and unused credits may be carried back one year
- You will continue to have use of your assets while you are alive
- A bequest is recocable and can be changed if your financial circumstances change

There are many different types of legacy gifts, also known as bequests or estate gifts.
Your Will must clearly indicate the recipient of your gift in order to successfully carry out your wishes.

General bequests are legacy gifts left to Clements Centre which come from the general value of the estate which are made by designating a specific dollar amount, a particular asset, or a fixed percentage of your estate to the charity

Specific bequests are made when a particular item or property is bequeathed for a designated purpose. (i.e., _____ is bequeathed to Clements Centre Society for its use; funds to be used in the operation of a particular program)

Residual requests are made when you intend to leave the residue portion (any leftover property of your assets to Clements Centre Society after other terms of your will have been satisfied

Contingency bequests allow you to leave a portion of your estate to Clements Centre Society if your named beneficiary does not survive you

Donation process

- Consult your professional advisors so that your gift reflects your overall estate and tax planning considerations
- Execute a fund agreement with Clements Centre Society
- Have your lawyer update or create your will to include a gift to Clements Centre Society (Charitable No. 107269466 RR 0001)
- Upon your death, Clements Centre Society will receive your gift and put it to work to support the Clements Centre priorities you specified in your fund agreement
- A receipt for tax purposes will be issued to your estate for the full fair-market value of your gift based on rules outlined in the Canada Income Tax Act

Your legacy gift will continue to make a difference for years to come

While there is no obligation to discuss your gift with Clements Centre Society, contacting us when you are planning a bequest will help ensure your wishes are understood when you are no longer able to make them clear.

It is also a good idea to make your loved ones aware of your intention to leave a bequest to Clements Centre Society. If you wish, they may be actively involved in the fund established through your estate.

Sample bequest clauses

The following sample bequest clauses are provided to assist you as you give thought to the type of gift you may want to leave to support Clements Centre Society. These are provided as examples only and should be reviewed by your professional advisors assisting with your estate and financial planning.

We strongly recommend contacting us to establish a fund agreement for your gift that clearly articulates your gift intent

It is important to name our charity accurately:

Clements Centre Society (Charitable Registry No. 107269466 RR 0001)

Examples:

Specific bequest (Gifts of cash)

I give [describe property as specifically as possible. For example, if the bequest is real estate, provide the street address and legal description. If the bequest is _____, provide an inventory listing] to Clements Centre Society (Charitable No. 107269466 RR 0001).

Residual bequest

I give the residual of my estate [or a specific portion of the residue] to Clements Centre Society (Charitable No. 107269466 RR 0001).

Contingent bequest

In the event that any bequest made by this Will shall, by reason of any beneficiary failing to survive me, or for any other reason, fail to take effect, the property so bequeathed is to go to Clements Centre Society (Charitable No. 107269466 RR 0001).
